***THIS IS THE CONTRACTUAL AGREEMENT FOR THE BREEDING OF THE ROTTWEILER BITCH***

The above-described Rottweiler bitch shall be bred to the stud dog BENNO VON DER SCHWARZEN HEIDE, SchH III, FH, IPO III, HD-, AD, ZTP, CGC, TT. 1987 German Bundesjungendsieger, 1989 Austrian Bundessieger, 1990 Worldseiger, 1990 Europasieger. OFA Good, OFA # RO-26848G54M-T, Eyes certified. BENNO was whelped on May 15, 1986. His American Kennel Club # WP357730/01. He is owned by Manson & Eve Johnson, P.O.Box 598, Land O'Lakes, Fl. 34639. Our telephone number is (813)996-5012. Our fax number is (813)996-2831.

The following are the requirements that the bitch must meet in order to be inseminated by BENNO's semen. Von Evman is members of the ADRK, USRC, ARC and as such try to adhere to the German Breeding Regulations with the realization that we are in the United States and most modify some of the German regulations due to practical considerations:

- 1.) The bitch must be at least two years old.
- 2.) The bitch must be proven to be free of Hip Dysplasia as evidenced by an OFA certification or equivalent certification from the bitch's country of origin.
- 3.) The bitch MUST have full correct dentition, correct eye color and shape, correct mouth pigmentation, and fit the German Standard for the Rottweiler.
- 4.) The bitch must be of sound, stable temperament. It is recommended that the bitch pass a Breed Suitability Test, Temperament Test, or have achieved a Schutzhund title or AKC obedience title, or basic obedience or companion dog title.
- 5.) The bitch must be in good health as evidenced by an updated veterinary examination which MUST include the following items:
  - A.) Current Brucellosis test.

- B.) Current vaginal cytology & culture demonstrating what stage of the estrus cycle the bitch is in and whether or not any bacterial diseases are present in the vagina that may cause venereal diseases or problems with her conceiving.
- C.) Current listing of vaccinations she has been given.
- D.) Any medical information available in case an emergency arises.
- 6.) The bitch should be groomed, bathed, and dipped before she is shipped to us to be bred.
- 7.) A copy of her pedigree, AKC or Foreign Registration Certificate, and photos showing front, rear, & side should be provided to us.

***The STUD fee for BENNO is \$ 3000.00 to be paid when the bitch is delivered by owner or before semen is shipped to the suggested location. ONLY ONE BITCH IS USED WITH THE SHIPPING OF SEMEN. If it is used on more than one bitch, a stud service is to be given for each bitch. The stud fee is no way refundable.***

Von Evman is limited on the amount of frozen semen collected from BENNO. We will therefore release only the amount of frozen semen straws recommended by the storage veterinarian per stud service. All transportation charges and veterinary expenses will be the responsibility of the owner of the bitch. We will supply pedigrees, photographs, and promotional materials of BENNO. For a fee, if requested, we will aid in the placing of puppies into good homes as a result from this mating. The owner of the bitch is responsible for all the vet bills and the expenses for the insemination to the appropriate location. we request for the veterinarian to do vaginal cytology, progesterone, and LH test on your female. These tests can be acquired from International Canine Genetics. The phone #'s for ICG is: 1-800-248-8099 or 1-215-640-1244, Fax # 610-640-1313. Multiple progesterone tests need to be sent to a competent lab.

The owner of the bitch warrants that his/her bitch has not been exposed to any stud dog prior to her breeding and that he/she will protect her from exposure after her insemination.

The owner of the bitch hereby releases from responsibility Eve's Garden Inc. D/B/A/ Von Evman Rottweilers, Manson and Evie Johnson, or its officers from any and all liabilities and/or damages to said bitch or semen.

THIS CONTRACT SHALL BE DEEMED A LEGALLY-BINDING CONTRACT AND IS UNDER THE JURISDICTION OF ONLY THE STATE OF FLORIDA, IN THE COUNTY OF PASCO. IT IS FURTHER AGREED THAT THE PLACE OF VENUE SHALL BE PASCO COUNTY, FLORIDA.***
