The above - described Rottweiler bitch shall be bred to the stud dog **KRIKAROTT JOCKEY VOM BLACKRIESEN, IPO I, BH, AD, ZTP, BST, TT, CGC, E, HD-, ED-, OFA EXCELLENT, Elbows, Shoulders, Eyes, Heart, Patella Certified.** Jockey is multiple V-1 rated in conformation, AKC and uci International Champion, CKC Pointed. Jockey was whelped on April 6,1996. His American Kennel Club Registration # WP886976/01. His OFA Registry #RO-56587E27M-T. His CHIC# is:19244. The following are the requirements that the bitch must meet in order to be inseminated to Jockey's semen. We are members of many clubs and as such try to adhere to the International Breeding Regulations with the realization that we are in the United States and must modify some of the International regulations due to practical considerations:

If you need assistance or knowledge on any of these regulations below, Von Evmans will be glad to guide you or your Veterinarian.

- 1.) The bitch must be at least two years old.
- 2.) The bitch must be proven to be free of Hip Dyplasia as evidenced by an OFA Certification or equivalent certification from the bitch's Country of origin.
- 3.) The bitch **MUST** have full correct dentition, correct eye color and shape, correct mouth pigmentation, and fit the International Standard for the Rottweiler. A copy of the International Standard will be provided upon request.
- 4.) The bitch must be of sound, stable temperament.
- 5.) The bitch must be in good health as evidenced by an updated veterinary examination which should include the following items:
  - A.) Current Brucellosis test.
  - B.) Current vaginal cytology demonstrating what stage of the estrus cycle the bitch is in.
  - C.) Culture and herpes titer to tell whether or not any bacterial diseases are present in the vagina that may cause venereal diseases or problems with her conceiving.
- 7.) A copy of her pedigree, AKC or Foreign Registration Certificate, and photos showing front, rear, & side should be provided to us.

The STUD fee for Jockey's semen is \$3000.00 to be paid before the semen is shipped to the suggested location. Only one bitch is used with the shipping of this semen. If it is used on more than one bitch, a stud service is to be given for each bitch. THE STUD FEE IS NO WAY REFUNDABLE.

Von Evman is limited on the amount of frozen semen collected from Jockey. We will therefore release enough straws recommended by the storage veterinarian per stud service. All transportation charges and veterinary expenses will be the responsibility of the owner of the bitch. Pedigrees, photographs, and promotional materials of Jockey will be available to download from our website. For a fee, if requested, we will aid in the placing of puppies into good homes as a result from this mating. The owner of the bitch is responsible for all the vet bills insemination and the expenses for the semen shipment to the appropriate location. We request for the veterinarian to do vaginal cytology, progesterone, and LH test on your female. These tests can be acquired by your veterinarian from Symbiotic Laboratories at: 1-800-796-2468, Fax # 858-675-2421. Multiple progesterone and LH tests must be done on the female and sent out to a competent lab.

The owner of the bitch warrants that his/her bitch has not been exposed to any stud dog prior to her insemination and that he will protect her from exposure through her heat cycle.

The owner of the bitch hereby releases from responsibility Eve's Garden Inc. D/B/A/ Von Evman Rottweilers, Manson and Evie Johnson & Gyorgy Csermely, or its officers from any and all liabilities and/or damages to said bitch or semen while this breeding is taking place.

SHOULD IT BECOME NECESSARY TO ENFORCE ANY PART OF THIS CONTRACT BY LEGAL MEANS, APPROPRIATE ATTORNEY'S FEES, COURT COSTS, AND TRAVEL EXPENSES WILL BE THE RESPONSIBILITY OF THE OWNER. THIS CONTRACT SHALL BE DEEMED A LEGALLY-BINDING CONTRACT AND IS UNDER THE JURISDICTION OF ONLY THE STATE OF FLORIDA, IN THE COUNTY OF PASCO. IT IS FURTHER AGREED THAT THE PLACE OF VENUE SHALL BE PASCO COUNTY, FLORIDA.
