The following are the requirements that the bitch must meet in order to be bred to Karthago. We are members of many clubs and as such try to adhere to the International Breeding Regulations with the realization that we are in the United States and must modify some of the International regulations due to practical considerations:

If you need assistance or knowledge on any of these regulations below, Von Evmans will be glad to guide you or your Veterinarian.

- 1.) The bitch must be at least two years old.
- 2.) The bitch must be proven to be free of Hip Dysplasia as evidenced by an OFA Certification or equivalent certification from the bitch's Country of origin.
- 3.) The bitch MUST have full correct dentition, correct eye color and shape, correct mouth pigmentation, and fit the International Standard for the Rottweiler. A copy of the International Standard will be provided upon request.
- 4.) The bitch must be of sound, stable temperament.
- 5.) The bitch must be in good health as evidenced by an updated veterinary examination which MUST include the following items:
  - A.) Current Brucellosis test.
  - B.) Current vaginal cytology demonstrating what stage of the estrus cycle the bitch is in.
  - C.) Current vaginal culture to determine any bacterial diseases or mycoplasma present in the vagina that may cause venereal diseases or problems with her conceiving or giving the disease to the stud dog.
  - D.) Current listing of vaccinations she has been given.
  - E.) Any medical information available in case an emergency arises.
  - F.) Current herpes titer.
- 6.) The bitch should be groomed, bathed, and dipped before she is shipped to us to be bred.
- 7.) A copy of her pedigree, AKC or Foreign Registration Certificate, and photos showing front, rear, & side should be provided to us.

The STUD fee for Karthago is \$ \_\_\_\_\_ to be paid when the bitch is delivered by the owner before the breeding is to take place unless otherwise agreed upon. If a breeding or insemination takes place the stud fee is no way refundable.

We guarantee that an actual mating or insemination will occur and that live sperm are found in the bitch immediately after mating as evidenced by microscopic examination. If the bitch fails to conceive a return service at NO CHARGE will be given to this bitch provided the owner notifies us within 10 days after the projected whelping date that no puppies were whelped. The owner of the bitch will still be responsible for any additional charges listed below. If the bitch does not whelp two live puppies, then a repeat stud service to the original bitch or a mutually agreeable bitch is given at a mutually agreeable time. This must be done the next heat cycle of the female. All transportation charges, tests and veterinary expenses will be the responsibility of the owner of the bitch. There is NO CHARGE for boarding the bitch for seven days, after the charge will be \$20.00 per day. This fee includes water, food, and exercise. We will supply pedigrees, photographs, and promotional materials to be downloaded from our website of Karthago and will aid in the placing of puppies into good homes for a fee as a result from this mating. If the bitch did not conceive and a repeat breeding is due and Karthago passes away then another stud dog owned by Von Evman Rottweilers will be chosen by the owner of the bitch to complete this contract. If the stud fee of the chosen dog cost is more or is co-owned by another person then the owner of the bitch must pay the difference.

The owner of the bitch warrants that his/her bitch has not been exposed to any stud dog prior to her arrival and that he will protect her from exposure upon her return home.

The owner of the bitch hereby releases from responsibility Eve’s Garden Inc. D/B/A/ Von Evman Rottweilers, Manson and Evie Johnson, or its officers from any and all liabilities and/or damages to said bitch while she is in the care of Von Evman Rottweilers for breeding or during her pregnancy.

SHOULD IT BECOME NECESSARY TO ENFORCE ANY PART OF THIS CONTRACT BY LEGAL MEANS, ANY, AND ALL ATTORNEY’S FEE, COURT COSTS, AND TRAVEL EXPENSES WILL BE THE RESPONSIBILITY OF THE OWNER OF THE BITCH. THIS CONTRACT SHALL BE DEEMED A LEGALLY-BINDING CONTRACT AND IS UNDER THE JURISDICTION OF ONLY THE STATE OF FLORIDA, IN THE COUNTY OF PASCO. IT IS FURTHER AGREED THAT THE PLACE OF VENUE SHALL BE PASCO COUNTY, FLORIDA.
